

# Distributions update

## Information about June distributions

As you have an investment with Advance, we have some information you may find useful.

We've reviewed the estimates of distributions due to be paid at the end of the financial year, and confirm that the financial year-end distributions are coming solely from income. The absence of any capital distribution is the result of capital losses being carried forward from prior years.

Please note, however, the estimates we've used are as at early May 2010. They are only a guide to the actual distributions, so the figures may change based on trading activity in the remaining period to 30 June.

## 31 March 2010 special distribution payments

As a reminder, we paid special distribution payments to all unit holders in the following funds on 31 March 2010.
